



List of the types of waste that are prohibited from receiving and handling at the port:

- Radioactive or explosive waste.
- Electronic waste.
- Medical waste.
- All types of bulbs (fluorescent neon led-).

Timings for providing ship waste reception services:

Ship waste reception services are provided at the port seven days a week, and all vehicles and waste transport vehicles operate by land 24 hours a day.

Requirements and procedures for issuing Licenses for contractors

- All contractors receiving and handling ship-generated wastes shall obtain Licenses from the Port Authority to work in the activities of port reception facilities. The following are the requirements for issuing licenses to contractors.
- 2- Contractors shall fulfill all required documents to issue the work licenses as follows:
 - A copy of ID and the criminal records Certificate.
 - Contract of establishment of the activity.
 - Evidence of ownership of the company.
 - Evidence of Membership in a Chamber of shipping.
 - An official extract of the Commercial register stating the activity of contractor.
 - Tax card stating the activity of contractor.
 - 5 Obligations according to decree NO. 800 from the year 2016.
- 3- The capital should be at least 250,000 L.E for each type of activity.
- 4- The Licensed contractors shall provide insurance of 5,000 LE in cash or by means of an unconditioned guarantee letter for the port authority which can be collected back at the expiry of the work license.
- 5- The applicant shall pay (3000) L.E for issuance / renewal of work license for each type of activity (marine contracting – marine supplies) and an amount of (3000) L.E for place utilization.
- 6- Work license is valid for 3 years and may be renewed for a similar period incase of fulfilling requirements and conditions.
- 7- All companies transferring ship-generated wastes from the port to the final disposal facilities shall obtain the required environmental permissions to practice this activity as well as safe disposal contract of those wastes from the Egyptian Environmental Affairs Agency.
